“Methodological innovation applied to promote the active aging”

CALL FOR PROPOSAL VP/2012/007 Social Policy Experimentations.

Improve the quality and effectiveness of social policies and facilitate their adaptation to new social needs and societal challenges

OBJETIVES

To promote the active aging in small municipalities (max. 10.000 inhabitants) through the development and the set up of an investigation – action ad hoc methodology. In order to:

- facilitate the change of perception in relation the role of the old people in their community
- To generate networks to promote their participation and the active involvement.
- To promote their empowerment.

The methodological design will be supported by the adaptation and the interrelation of several social researches and intervention skills:

- Deliverative surveys
- Community forum
- Research – action – participation

MAIN ACTIVITIES:

1. Study area identification.
2. Design - initial research: Analyse the social state (state of art, social skills, opinions, etc.)
 - Surveys elaboration.
 - Field work.
 - Analysis and interpretation of results.
3. Design of the framework and the contents of work..
4. Development of the community forum
- A. Dissemination of results of the initial research
- B. Strategies of promotion, organization and accompaniment of promotional activities of the active aging.
 - i. Voluntary groups.
 - ii. Self – help groups.
 - iii. Participatory training
 - iv. Intergenerational activities.
 - v. Good practices training.
5. Implementation of the post – forum questionnaires to the forum participants.
6. Actions to encourage and monitoring of the active aging promotional activities: Voluntary, self – help, participation, intergenerational actions.
Strengthening of the activities and consolidate the self – sufficient social fabric.
7. Final questionnaires implementation:
 - Participants collective
 - No participants collective (members of the community no involved in the project).
8. Measuring of impact of the developed activities.
9. Systematization and valuing of the implemented methodological plan.



PARTNERS.
